

VERIFIED COMPLAINT FOR INJUNCTIVE RELIEF

NOW COME the Plaintiffs, JOHN C. RICHARDS and GERALD T. MURPHY, by and through their attorney, Daniel J. Kelley, and complaining of the Defendants, EVANSTON WILMETTE GOLF COURSE ASSOCIATION, INC., an Illinois Not for Profit Corporation, and JOHN S. LOSASSO, allege and state as follows:

PARTIES
